### Section 3. Composition/Information on Ingredients

There are no additional ingredients present which, within the current knowledge of the supplier and in the concentrations applicable, are classified as hazardous to health or the environment and hence require reporting in this section.

### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

- General Advice:** Move out of dangerous area. Call a POISON CENTER or doctor/physician immediately. Show this safety data sheet to the doctor in attendance. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

### Section 8. Exposure Controls/Personal Protection

**Engineering Controls:** Properly operating explosion-proof, chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

**Environmental Exposure Controls:** Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. 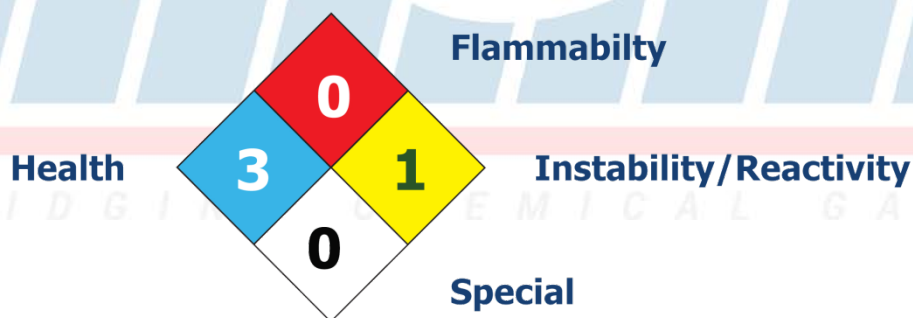
